**Notice to the Office of the Prosecutor of the International Criminal Court  
regarding Crimes against Humanity committed by the Palestinian  
Authority against Palestinian citizens in the West Bank**

## Introduction

We, the Jerusalem Institute of Justice (“JIJ”), submit to the Office of the Prosecutor (“OTP”) of the International Criminal Court (“ICC” or “Court”) testimonies and affidavits of 52 Palestinian civilians who have suffered the grave atrocities of arbitrary imprisonment, torture, and murder by the Palestinian Authority (“PA”) during the time period of 1991 to 2004.

On July 17, 2017, the Jerusalem District Court found the PA liable for unlawful imprisonment in a precedent-setting ruling and ordered the PA to compensate the 52 plaintiffs.<sup>1</sup> The victims, suspected by the PA of “collaboration with Israel,” suffered extreme physical and emotional trauma that has caused numerous long-term damages. The court found all testimonies reliable. The exact amount of compensation is yet to be determined.

On February 20, 2019, the JIJ submitted to the OTP a communication pursuant to Article 15 of the Rome Statute of the ICC concerning Mahmoud Abbas in relation to the alleged crimes against humanity of murder, torture, and unlawful imprisonment. Those crimes were committed through a systematic and widespread campaign against parts of the Palestinian population in the West Bank from February 2011 through February 2019.

The “State of Palestine” deposited a retroactive ad hoc submission to the ICC’s jurisdiction under Article 12(3) of the Rome Statute on January 1, 2015. According to the Article 12(3) declaration, the ICC has jurisdiction over crimes committed on the territory of the “State of Palestine” from June 13, 2014 onwards.<sup>2</sup> This date was intentionally selected to prevent the Court from holding the “State of Palestine” accountable for the murder of three Israeli teenagers on June 12, 2014 and for earlier cases of torture in the West Bank.

In addition to territorial jurisdiction, the ICC also has personal jurisdiction over crimes allegedly committed in the territory of the “State of Palestine.” Mahmoud Abbas has held Jordanian

citizenship/nationality since 2011, and Jordan has been a State Party to the Rome Statute since 2002. Therefore, the ICC may exercise jurisdiction over crimes he has committed since becoming a Jordanian citizen/national, regardless of where they occurred.<sup>3</sup>

The JIJ is aware of the fact that the crimes against humanity testified to by the 52 Palestinians and submitted with this notice do not fall under the temporal jurisdiction of the ICC since they occurred before 2014. However, the JIJ is firmly convinced that the testimonies prove that a mechanism of systematic torture and unlawful imprisonment has been used by the PA for many years, well before 2014, and is still in place.

Abbas became president of the PA in 2005 and continues to preserve Yasser Arafat's regime of suppression of political enemies. Therefore, this notice supports the allegations against Mahmoud Abbas which were detailed in the communication submitted on February 20, 2019, and completes the picture of widespread and systematic crimes against humanity directed against the civilian population of the West Bank.

## Chart of Testimonies

**Red Text:** Signifies that the victim died either during or after the torture

\*The repeatedly mentioned Shabach Method of torture includes cuffing the victim's hands, typically in abnormal/uncomfortable positions, covering the head, and playing extremely loud music. In many testimonies, torturers also hung victims from the ceiling as part of the method.

^The Chinese Water Torture method includes physically restraining a prisoner and dripping water on the head, one drop at a time, for an extended period of time.

All victims were assessed by professional, licensed psychologists and psychiatrists. These reports are based on the findings of those professionals. Each torture victim reported the organization by whom they were tortured and, in some cases, mentioned specific names of people involved.

- 97% of the prisoners reported having been tortured by the Palestinian Authority (PA). In many cases, that was the only organization mentioned, however some prisoners were able to identify more specific forces within the PA's structure.
- 11 of the victims specifically mentioned the Palestinian Authority's Preventive Security Forces, calling them "Amin al Wakai."
- 8 of the victims reported people from the PA's either general or military intelligence services.
- 2 of the victims mentioned the PA's "Force 17" unit.
- 4 of the victims mentioned Palestinian police forces or the police/security forces of the specific city in which they were arrested/imprisoned.

## Legal and Factual Analysis

These cases constitute crimes against humanity according to Article 7 of the Rome Statute, specifically Article 7(1)(a), (e) and (f). The elements of this crime and its application to the facts will be specified in the following chapters.

### A. "Widespread or Systematic"

Article 7(1) of the Rome Statute requires that for an attack to be considered a crime against humanity, it must be either "*widespread or systematic.*" "*Widespread*" refers to the "*large-scale nature of the attack, which should be massive, frequent, carried out collectively with considerable seriousness and directed against a multiplicity of victims.*"<sup>4</sup> "*Systematic*" refers to "*the organized nature of the acts of violence and the improbability of their random occurrence.*"<sup>5</sup>

This notice documents ample cases to demonstrate the widespread nature of the attacks. Abundant testimony exhibits that crimes against humanity have been carried out in different places over the West Bank for over a decade. The commission of crimes such as murder, torture, and unlawful imprisonment against political opponents in the furtherance of a wider campaign to subdue and discourage dissent with the PA is compelling evidence that those crimes were systematic in nature. A Human Rights Watch report states: *“In the 25 years since Palestinians gained a degree of self-rule over the West Bank and the Gaza Strip, their authorities have established machineries of repression to crush dissent, including through the use of torture.”*<sup>6</sup> The relevant incidents are not limited and random. Instead, they have been and continue to be part of the PA’s governmental policy.

#### B. “Attack Directed Against Any Civilian Population”

For an attack to amount to a crime against humanity it must be *“directed against any civilian population”* according to Article 7(1) of the Rome Statute. The ICC Pre-Trial Chamber held that: *“The commission of the acts referred to in article 7(1) of the Statute constitute the ‘attack’ itself and, beside the commission of the acts, no additional requirement for the existence of an ‘attack’ should be proven.”* An attack need not be a military act but can be a *“campaign or operation carried out against the civilian population.”*<sup>7</sup>

For an attack to be directed against a civilian population, multiple instances of the relevant crimes enumerated in Article 7(1) must have been committed, in the form of a *“policy to commit such attack.”*<sup>8</sup> A single isolated incident will not qualify. It is required that *“the State or organization actively promote or encourage such an attack against a civilian population.”*<sup>9</sup> The term ‘civilian

population' is defined in Article 50(1) of the Additional Protocol I of the Geneva Convention as, *inter alia*, anyone who is not part of an armed force, member of militia or volunteer corps, and who is not engaging in the customs of war (for example, carrying arms openly).<sup>10</sup> The Pre-Trial Chamber has further stated that *"the population targeted can include a group defined by its (perceived) political affiliations."*<sup>11</sup> The civilian population against which the attacks by the PA are directed is the Palestinian population of the West Bank. The attacks have specifically been aimed at individuals who do not cooperate with and/or do not support the PA government, especially against persons who are thought to be supporting or assisting Israel. Hence, the immediate victims of such crimes are various suspected or known political opponents, but the wider class of victims is the entire Palestinian population in the West Bank who are intimidated into submitting to the PA's regime. Therefore, the attacks carried out by the PA are directed against specific groups within the Palestinian population, defined by their (real or perceived) political affiliations.

### C. "With Knowledge of the Attack"

Article 7(1) of the Rome Statute requires that for crimes against humanity to be committed, there must be "knowledge of the attack." The perpetrator must have knowledge *"that the conduct was part of or intended the conduct to be part of a widespread or systematic attack against a civilian population."*<sup>12</sup> However, the perpetrator need not know all the characteristics or precise details of the plan, policy, or attack of the State or organization to have the requisite participation in and knowledge of a widespread or systematic attack against a civilian population. The mental element in the intent clause *"is satisfied if the perpetrator intended to further such an attack."*<sup>13</sup>

The perpetrators of the underlying criminal acts had the requisite knowledge and intent to fulfill Article 7(1) of the Rome Statute. That the acts of violence and intimidation described herein were

carried out predominantly against individuals politically opposed to the PA is strong prima facie evidence that those carrying out the individual actions knew precisely why such individuals were singled out for abuse; it was not a random selection.

#### D. Murder

The ICC's Element of Crimes provides that for the crime of murder to constitute a crime against humanity, the following factors must be present:

- "1. The perpetrator killed one or more persons.*
- 2. The conduct was committed as part of a widespread or systematic attack directed against a civilian population.*
- 3. The perpetrator knew that the conduct was part of or intended the conduct to be part of a widespread or systematic attack against a civilian population."*<sup>14</sup>

The perpetrator must have intended to engage in killing one or more persons, meant to cause death, or was aware that death would occur in the ordinary course of events.<sup>15</sup> The death of a victim must have occurred as a result of an act or of an omission of the perpetrator.<sup>16</sup> The Palestinian individuals' testimonies herein presented evidence the murder of one or more persons. The testimonies describe how individuals' friends, family, and other acquaintances have been killed by the PA Security Forces, partially as an intimidation method. One of the murders in question took place while the victim was in the custody of the police and/or security forces in Nablus Prison. Another murder occurred after the victim was freed from Jnaid Prison in Nablus. He was killed by Palestinian officials upon returning to PA territory. Overall, there have been four deaths as a result of the torture; two of the deaths were directly at the hands of the PA, and two were due to the psychological and physical effects of the torture. The requirements for crime against humanity of murder are hence fulfilled.

## E. Imprisonment

For imprisonment or other severe deprivation of personal liberty to amount to crimes against humanity, the following factors must be present:

- “1. The perpetrator imprisoned one or more persons or otherwise severely deprived one or more persons of physical liberty.*
- 2. The gravity of the conduct was such that it was in violation of fundamental rules of international law.*
- 3. The perpetrator was aware of the factual circumstances that established the gravity of the conduct.*
- 4. The conduct was committed as part of a widespread or systematic attack directed against a civilian population.*
- 5. The perpetrator knew that the conduct was part of or intended the conduct to be part of a widespread or systematic attack directed against a civilian population.”<sup>17</sup>*

Imprisonment is frequently associated with the commission of the crimes of murder and torture. The imprisonment of those who are deemed enemies of the PA is frequently a precursor for their torture and, in some case, death. Where such acts of imprisonment are conducted without a legal basis, it is indicated that they violate international criminal law. An initially lawful act may become unlawful when certain procedural rights and guarantees fail to be kept.<sup>18</sup> Legal imprisonment requires adherence to procedural codes. Police forces and public officials must be knowledgeable of these directives and are required to abide by them. When the local authorities uphold imprisonment contrary to judicial order, they knowingly participate in illegal behavior. All elements of the crime against humanity of imprisonment are therefore fulfilled.

## F. Torture

According to the ICC's Elements of Crimes, torture occurs where:

- "1. The perpetrator inflicted severe physical or mental pain or suffering upon one or more persons.*
- 2. Such person or persons were in the custody or under the control of the perpetrator.*
- 3. Such pain or suffering did not arise only from, and was not inherent in or incidental to, lawful sanctions.*
- 4. The conduct was committed as part of a widespread or systemic attack directed against a civilian population.*
- 5. The perpetrator knew that the conduct was part of or intended the conduct to be part of a widespread or systematic attack directed against a civilian population."*<sup>19</sup>

Article 7(1)(f) of the Rome Statute does not require any special purposes of inflicting pain and suffering upon the victim and is not limited to persons acting as, or with the consent or acquiescence of, a public official or in an official capacity.<sup>20</sup>

The element of inflicting severe physical or mental pain or suffering upon one or more persons is fulfilled by the actions of the PA's employees and agents. Each of the 52 testimonies submitted with this notice prove that physical and mental torture were employed by the PA during custody. The PA tortured the victims using a wide range of methods ranging from being hung from the ceiling and beaten repeatedly, to solitary confinement in restrictively small spaces, to forced sodomy with broken glass bottles.

The second condition for the crime against humanity of torture is that the victim be in custody or under control of the perpetrator. The testimonies show that the cases of torture and abuse occurred during the arrest process and/or during detention. Therefore, this criterion is clearly fulfilled.

The third criterion, namely that the pain and suffering did not arise from and was not inherent in or incidental to lawful sanctions, is met as well. Article 108 of the Penal Code and Article 280 of the PLO Revolutionary Law of 1979 actively criminalized torture, as defined in Article 1 of the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment of 1984.<sup>21</sup> Article 13 of the Palestinian Basic Law renders confessions made under torture invalid.<sup>22</sup> It also appears that the use of torture is an unlawful practice under the local Palestinian law, whereby the third criterion is also given. Furthermore, the use of torture in the West Bank by PA officials, including police officers and special forces, was widespread. Though placed in different jails in the West Bank, many prisoners described specific and uniform torture methods, showing consistency between jails. This is a strong indication that systematic torture was ordered from above, and not at the discretion of a single official.

## Admissibility on the Principle of Complementarity

### Introduction

In order for the Office of the Prosecutor (OTP) to open an investigation, it must verify the three admissibility requirements as set out in Article 53 of the Rome Statute; namely the principles of gravity, complementarity, and interest of justice. This report focuses on the principle of complementarity because it reveals a serious problem with the PA's claim to have a good, working independent judicial framework. In reality, the PA's government can and does control the judicial system to further political interests. Because of this absolute political control, there is no prospect of improvement regarding future investigations, prosecutions, or policy changes.

### Complementarity Article 17 of the Rome Statute

In the case of former Congolese warlord Germaine Katanga, the ICC Appeals Chamber established an empirical test to verify the complementarity requirement under Article 17 of the Rome Statute.<sup>23</sup> The Court considers the presence or the absence of national proceedings in the relevant state by asking the empirical question: "Are there on-going investigations or prosecutions, or have investigations been carried out and a decision made not to prosecute?"<sup>24</sup> In other words, did the State of Palestine conduct relevant national investigations of the alleged crimes against humanity committed against the 52 Palestinians in question? Unfortunately, the answer is no. The PA's officials enjoy an alarming level of impunity.

This is also what the Office of the United Nations High Commissioner for Human Rights (OHCHR) concluded in July 2017. He determined that the State of Palestine has not complied with the calls for accountability and he urged the State of Palestine to conduct a prompt, impartial, and independent investigation of all alleged violations of international human rights.<sup>25</sup>

Freedom House has reported in this regard that the allegations of torture and other abuse by PA security forces are common, and officers are rarely punished for such violations.<sup>26</sup> Amnesty International confirmed that the impunity for human rights abuses in the West Bank and Gaza have persisted and that no criminal investigations have successfully been launched.<sup>27</sup> Consequently, victims do not have any access to justice and reparations.

In summary, the relevant authorities have not competently exercised adequate judicial powers in their territory. Law enforcement officials systematically fail to open investigations or prosecute the PA's officers despite the judicial framework that is theoretically in place. Under Palestinian Basic Law, PA President Mahmoud Abbas, must authorize all judicial appointments. As a result, each serving judge owes his position and its continuity to Abbas. It is no surprise that these judges will not investigate Abbas' high officers, let alone prosecute them. Additionally, many systematic, politically-motivated crimes occur in penal institutions within the West Bank, all of which are controlled by the PA. We conclude that the PA's judicial framework is in the hands of the politicians who are abusing the system to further their own agendas. Therefore, there is no prospect of improvement regarding future investigations, prosecutions, or policy changes. An investigation by the OTP has the power to overturn this systematic injustice.

## Conclusion

In conclusion, all elements of the crimes against humanity of murder, imprisonment, and torture are satisfied. The testimonies submitted prove that crimes against humanity have been committed systematically under the PA's regime. The mechanical oppression of political opponents under Yasser Arafat has been continued by Mahmoud Abbas. It is evidenced that the same methods and mechanisms have been employed by the PA for more than 20 years. Therefore, it is of utmost importance to shine a light on these human rights violations committed by the PA. Hence, we respectfully submit that the evidence presented in this notice supports the allegations made against Mahmoud Abbas for crimes against humanity committed against the Palestinian population of the West Bank, and we call for the ICC to open a preliminary examination into this case.
